A BILL

To amend title 23, United States Code, with respect to vehicle weight limitations for certain vehicles hauling perishable commodities or products, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Freight Restriction
5 Elimination for Safer Hauling Act of 2019”.

1 **SEC. 2. VEHICLE WEIGHT LIMITATIONS-INTERSTATE SYS-**
2 **TEM.**

3 Section 127 of title 23, United States Code, is
4 amended by adding at the end the following:

5 “(v) VEHICLES HAULING PERISHABLE COMMOD-
6 ITIES OR PRODUCTS.—

7 “(1) IN GENERAL.—A State may waive the ap-
8 plication of any vehicle weight limit established
9 under this section with respect to a covered vehicle
10 hauling a perishable commodity or product.

11 “(2) DEFINITIONS.—In this subsection:

12 “(A) COVERED VEHICLE HAULING A PER-
13 ISHABLE COMMODITY OR PRODUCT.—The term
14 ‘covered vehicle hauling a perishable commodity
15 or product’ means a vehicle that—

16 “(i) is carrying—

17 “(I) a perishable agricultural
18 commodity (as defined in section
19 1(b)(4) of the Perishable Agricultural
20 Commodities Act, 1930 (7 U.S.C.
21 499a(b)(4));

22 “(II) concrete in an unhardened
23 state;

24 “(III) live poultry;

1 “(IV) raw or unfinished forest
2 products, including logs, pulpwood,
3 biomass, or wood chips;

4 “(V) livestock feed; or

5 “(VI) other products or commod-
6 ities that could be deemed not useful
7 after a specified amount of time in ac-
8 cordance with industry standards and
9 practices, as defined by a State;

10 “(ii) meets the weight tolerances (or
11 weight limits) and vehicle configurations of
12 the State in which the vehicle is operating
13 and, if applicable, point of origin radius
14 distances within the State boundaries in
15 which the vehicle is operating; and

16 “(iii) is equipped with speed-limiting
17 technology that is turned on and set at a
18 speed not greater than the lesser of—

19 “(I) the posted speed limit; or

20 “(II) 65 miles per hour.

21 “(B) SPEED-LIMITING TECHNOLOGY.—The
22 term ‘speed-limiting technology’ means a tech-
23 nology that prevents a commercial motor vehicle
24 from exceeding a preprogramed maximum
25 speed.”.
