Mr. BISHOP of Georgia introduced the following bill; which was referred to the Committee on _____

A BILL

To name the Department of Veterans Affairs community-based outpatient clinic in Columbus, Georgia, as the “Robert S. Poydasheff VA Clinic”.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FINDINGS.**

4 Congress makes the following findings:

5 (1) Former Columbus, Georgia, Mayor Robert
6 S. Poydasheff died on September 24, 2020.

7 (2) He earned a B.A. in Political Science from
8 the Citadel in 1954, a J.D. from Tulane University

1 Law School in 1957, an M.A. in International Rela-
2 tions from Boston University's Graduate Program in
3 Berlin, Germany, in 1967, and attended the Hague
4 Academy of International Law in the Netherlands in
5 preparation for a military and subsequent civilian
6 career that focused on serving others.

7 (3) In 1955, he was commissioned as a Second
8 Lieutenant in the Infantry Branch of the United
9 States Army, and he was reassigned to the Judge
10 Advocate General's Corps.

11 (4) He was a 1976 graduate of the United
12 States Army War College and served a total of 24
13 years, retiring as a Colonel in 1979.

14 (5) He was decorated with the Legion of Merit
15 with two Oak Leaf Clusters, the Bronze Star Medal,
16 and Vietnam Ribbon with Four Battle Stars, and
17 during his military career and because of his expert
18 legal acumen he was assigned to work on the biggest
19 cases of the time in which he served, but during this
20 he never lost sight of what he considered his primary
21 role, which was to take care of soldiers.

22 (6) Robert S. Poydasheff was appointed as legal
23 counsel to the Secretary of the Army and served the
24 needs of all soldiers by helping to shape Army policy.

1 (7) In 2012, the Army War College Foundation
2 named Colonel Poydasheff an Outstanding Alumnus
3 in recognition of his wide-ranging service to his com-
4 munity after his retirement from active duty.

5 (8) Colonel Poydasheff served on the Columbus,
6 Georgia City Council from 1994 to 2002, helping all
7 citizens of the community he had come to love while
8 concurrently serving Fort Benning and his beloved
9 soldiers.

10 (9) He was elected Mayor of Columbus, Georgia
11 in 2002, served a four-year term and maintained a
12 focus on community-based programs as well as
13 strengthening the relationship between the city and
14 Fort Benning.

15 (10) During that time he made great contribu-
16 tions to the joint military and civilian communities
17 of Columbus, Georgia, and Fort Benning, appointing
18 first a fellow soldier and later the first African
19 American to the City Manager position, while know-
20 ing that doing so would be at his own political peril.

21 (11) After his service as Mayor of Columbus,
22 Georgia, Robert S. Poydasheff found continued suc-
23 cess as a practicing lawyer helping countless citizens
24 and soldiers living in the city he once led as well as
25 advocating for many soldiers in the area.

1 (12) His continued interest in the betterment of
2 the city as well as his contributions to the Veterans
3 Action Committee has a continued impact to this
4 day.

5 (13) He served as past president of the Chat-
6 tahoochee Council Boy Scouts of America, past
7 president of the Chattahoochee Valley Association of
8 the United States Army, past president of the Colum-
9 bus Symphony Orchestra, member of the Board of
10 Directors of the Springer Opera Arts Association,
11 past president of the Ann Elizabeth Shepherd
12 Home, and member of the Kiwanis Club and Colum-
13 bus Bar Association.

14 **SEC. 2. NAME OF DEPARTMENT OF VETERANS AFFAIRS**
15 **COMMUNITY-BASED OUTPATIENT CLINIC, CO-**
16 **LUMBUS, GEORGIA.**

17 The Department of Veterans Affairs community-
18 based outpatient clinic located at 6910 River Road, Co-
19 lumbus, Georgia, shall after the date of the enactment of
20 this Act be known and designated as the “Robert S.
21 Poydasheff VA Clinic”. Any reference to such clinic in any
22 law, regulation, map, document, record, or other paper of
23 the United States shall be considered to be a reference
24 to the Robert S. Poydasheff VA Clinic.
