**A BILL**

To amend title 10, United States Code, to modify the semi-  
annual report on privatized military housing, and for  
other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Military Housing Per-  
5       formance Insight Act”.

1 **SEC. 2. MODIFICATION OF SEMI-ANNUAL REPORT ON**  
2 **PRIVATIZED MILITARY HOUSING.**

3 (a) IN GENERAL.—Subsection (c) of section 2884 of  
4 title 10, United States Code, is amended by adding at the  
5 end the following new paragraphs:

6 “(15) An overview of the housing data being  
7 used by the Department and the housing data being  
8 sought from management companies.

9 “(16) An assessment of how the Secretary of  
10 each military department is using such housing data  
11 to inform the on-base housing decisions for such  
12 military department.

13 “(17) An explanation of the limitations of any  
14 customer satisfaction data collected (including with  
15 respect to the availability of survey data), the proc-  
16 ess for determining resident satisfaction, and rea-  
17 sons for missing data.

18 “(18) To the maximum extent practicable, a  
19 breakdown of the information under this paragraph  
20 by installation and military housing project.”.

21 (b) PUBLIC REPORTING.—Such subsection is further  
22 amended—

23 (1) in paragraph (14), by redesignating sub-  
24 paragraphs (A) through (D) as clauses (i) through  
25 (iv), respectively;

1           (2) by redesignating paragraphs (1) through  
2           (18) as subparagraphs (A) through (R), respectively;  
3           (3) in subparagraph (E), as redesignated by  
4           paragraph (2), by striking “paragraphs (1) through  
5           (4)” and inserting “subparagraphs (A) through  
6           (D)”;

7           (4) in the matter preceding subparagraph (A),  
8           as so redesignated, by striking “The Secretary” and  
9           inserting “(1) The Secretary”; and

10          (5) by adding at the end the following new  
11          paragraph:

12          “(2) Not later than 30 days after submitting a report  
13          under paragraph (1), the Secretary of Defense shall pub-  
14          lish the report on a publicly available website of the De-  
15          partment of Defense.”.

16          (c) TECHNICAL AMENDMENT.—The heading for such  
17          subsection is amended by striking “ANNUAL” and insert-  
18          ing “SEMI-ANNUAL”.

19          (d) CONFORMING AMENDMENT.—Subsection (d)(1)  
20          of such section is amended by striking “paragraphs (1)  
21          through (14) of subsection (c)” and inserting “subpara-  
22          graphs (A) through (R) of subsection (c)(1)”.
